Bad weekend in wilderness

This last weekend proved a dangerous one on the mountain, accenting the divide between the stark challenges of the wilderness and the relative safety of more manicured environments.

Sunday, Nov. 11, according to Glenda Yates, Riverside Mountain Rescue Unit (RMRU), an unidentified woman and her children, hiking on Deer Springs Trail, discovered the body of a deceased male, who Yates said authorities believed had been dead for about a week.

The female hiker used her cell phone to notify authorities. Yates said there had been no missing hiker reports called in either to the Riverside County Sheriff's Department or to RMRU, so the discovery came as a surprise.

VHS may declare bankruptcy

"Everything is on the table," said Patrick Searl, president of Valley Health Systems, when asked if bankruptcy is a consideration now that Measure G has failed. Layoffs, reduced services and possible bankruptcy may be necessary to quell the district's hemorrhaging finances.

For the 12 months from July 1, 2006, to June 30, 2007, VHS lost \$11.8 million. Since July 1, VHS has lost more than \$8 million. The losses are accelerating. The board believed the problem would be solved with the sale of assets to Select Healthcare Solutions of Del Mar.

Select, headed by Matthew Cutler, was prepared to buy the three hospitals and long-term care facility for \$135 million. In addition, Cutler planned to add a professional hospital management firm to his team and find deep-pocketed investors. The latter were prepared to put up the necessary funds to retrofit Hemet Valley Medical Center and build new facilities, such as a cardiac center.
